Important Information:

The UK high commission has introduced the Biometric system (Fingerprints & Digital Photo) to apply for all UK visas & all applicants have to visit respective facilitation centre of Embassy/Consulate for the same.

Ensure your fingertips are free from any forms of decoration, cuts, abrasions or other markings as these may affect your ability to provide acceptable finger scans.

If you are applying for a visa on behalf of a child under 5 years old, they must also attend an appointment, but don't have to provide their fingerprint information

Submission @ Pune VFS

Travel Agents are not allowed to submit documents at VFS, hence applicant will have to go personally to submit application and for Bio-Metric Finger print at Pune VFS.

Following applicants are exempted from biometrics:

- Children under 5 years of age
- Applicants for whom the collection of fingerprints is physically impossible

Processing Time:

Fast Track / Priority Visa Service:

The UK Border Agency will expedite the processing of your visa application and return of your documents. Customers may request this service if they are applying for a visitor visa (excluding student visas) and have travelled without difficulty in the last five years to one of the following countries: UK, US, Australia, New Zealand, Canada or a Schengen country.

Please note: If you have been refused a visa for any one of these countries or overstayed your visa to the UK or been removed or otherwise been required to leave the UK, the processing of your application is likely to take longer than the processing times set out below, and is unsuitable for the Fast Track process

Processing times:

Fast track basis 5 to 7 working days.

The cost for Fast Track service is Rs.20836/- in addition to the above mentioned Charges.

Note: - Further, any change in fees, additional document or personal presence of the applicant might be required which is on the discretion of the embassy or consulate.

Note: Using the Fast Track service does not guarantee that your visa application will be successful. All applicants must meet the requirements of the UK's Immigration Rules. The Fast Track fee will not be refunded if the visa is refused or, in exceptional circumstances, takes longer than the processing times set out above.

Important Note:

- 1) Granting or refusing the visa is at sole discretion of respective Embassy/Consulate/High commissions.
