11	If the applicant is a minor (below 14 years of age), please bring a recent photograph to the biometric appointment. The photograph must comply with the specifications mentioned below: Photo Specifications for U.S. Visa Renewal • Size: 2 x 2 inches (51 x 51 mm) • Head dimensions: Between 1 inch and 1 3/8 inches (25 mm to 35 mm) from chin to top of head • Background: Plain white or off-white • Color: Must be in color (no black-and-white photos) • Recency: Taken within the last 6 months • Quality: High-resolution, no blurriness, graininess, or pixelation • Expression: Neutral facial expression or natural smile, both eyes open • Pose: Face the camera directly, full face in view	

What to Avoid

- **Glasses:** Not allowed unless medically necessary (must include a signed doctor's note)
- **Headwear:** Not permitted unless worn daily for religious or medical reasons (requires a signed statement)
- **Uniforms or camouflage:** Not allowed; wear everyday clothing
- **Filters or digital alterations:** Strictly prohibited
- **Selfies:** Not acceptable—have someone else take the photo
