Institutional guarantine: For symptomatic passengers as advised by health authorities

Home quarantine

• For all International passengers except passengers coming through flights originating from the United Kingdom, Brazil, South Africa, Europe and Middle East are advised to self-monitor their health for 14 days.

• All such passengers shall inform the State or National Call Centre in case they develop symptoms at any time during the quarantine or self-monitoring of their health.

• For All international passengers coming or transiting from flights originating from the United Kingdom, Brazil, South Africa has to give their sample in the designated area and exit the airport only after confirmation of a negative test report.

• Transit passengers from the United Kingdom, Brazil and South Africa who are found negative on testing at the airport shall be allowed to take their connecting flights and advised quarantine at home for 14 days.

• Non-Transit passengers shall give samples at the designated area and exit the airport.

• All other passengers from the Middle East who have to exit the destination airport or take connecting flights to their final domestic destination shall give samples at the designated area and exit the airport. If the test report is negative, they will be advised to self-monitor their health for 14 days. If the test report is positive, they will undergo treatment as per standard health protocol.

Health screening

- Thermal screening for all international arrivals.
- COVID-19 test (RT-PCR) at Airport.

• In respect of transit passengers from the United Kingdom, South Africa and Brazil and who have tested negative in transit Airport in India, they shall give a sample for testing and leave the Airport.

Covid test

• For all symptomatic passengers as advised by health authorities.

 All international passengers coming/transiting from flights originating from the United Kingdom, Brazil, South Africa will give their sample in the designated area and exit the airport only after confirmation of a negative test report.

• All International passengers from the Middle East who have to exit the destination airport or take connecting flights to their final domestic destination shall give samples at the designated area and exit the airport.

Passenger obligation

 All International passengers should submit Self-Declaration form on the online AirSuvidha portal (www.newdelhiairport.in)

• All passengers should upload a negative COVID-19 RT-PCR report. This test should have been conducted within 72 hours prior to undertaking the journey.

• All International travelers coming/transiting from flights originating from United Kingdom, Brazil, South Africa and Middle East should submit Self-Declaration Form (SDF) on the online Air Suvidha portal (www.newdelhiairport.in) before the scheduled travel and to declare their travel history (of past 14 days).

Airline obligation: Ensuring passengers are complying with the state guidelines including RT-PCR test reports prior boarding.

Airport or State obligation: Implementation of travel guidelines issued by state authorities. Test facility at Airport.

• All passengers originating or transiting through the United Kingdom, Europe or Middle East shall adhere to Undergo molecular test upon arrival at their own cost and proceed towards home quarantine or self-health monitoring or take onward connecting flights to the final destination within India.

• All passengers originating from United Kingdom, South Africa or Brazil shall adhere to below guidelines

• In case the journey ends at the first port of entry into India, they need to undergo RT-PCR test. Passengers shall be permitted to exit the airport only if the test result is negative.

• Incase of onward connection, passengers shall have to wait for the RT-PCR test results. Onward journey shall be permitted only if the test result is negative.





• Those coming as transit passengers from the United Kingdom, Brazil and South Africa who are found negative on testing at the airport shall be allowed to take their connecting flights and advised quarantine at home for 7 days.

- Self-paid COVID-19 test (RT-PCR/TrueNat) at Airport

 In respect of transit passengers from the United Kingdom, South Africa and Brazil whose final destination is Tamil Nadu and who have tested negative in transit airports in India, they shall give samples for testing and leave the Airport. Follow up action shall be taken up by the Director of Public Health and Preventive Medicine based on the test report.

Institutional quarantine

In addition to carrying of RT-PCR negative report with sample taken 48 hrs prior to departure, all incoming passengers are tested with RT-PCR at free of cost at ITF ground and those who are tested positive, will be institutionally quarantined at free of cost or will have the option to stay at identified hotels on payment basis.

Home quarantine

- All incoming passengers from mainland to undergo compulsory home quarantine or institutional quarantine until the reports of their test on arrival at Port Blair are found negative.
- Any person violating the above directions shall be liable to be fined to the tune of Rs.5000/each time

Health screening: Not required

Covid test

• All incoming passengers aged above 1 year shall mandatorily carry RT-PCR negative test report issued from an ICMR-approved Labs, subject to the condition that RT-PCR test should have been taken within 48 Hrs prior to commencement of journey and produce the Test Result /Report at the originating station and also at ITF ground at Port Blair Airport for verification with SRF ID No. for validation.

 In addition to the above, the RT-PCR Test will be conducted on all incoming passengers at ITF ground by transporting the passengers to the ITF ground in buses by the administration.

• The report of RT-PCR conducted at ITF ground will be available in 1-3 days via phone number provided in the Self Declaration Form.

• All incoming passengers from mainland to undergo compulsory home quarantine or institutional quarantine until the reports of their test on arrival at Port Blair are found negative.

• If tested positive, Positive tested passengers shall be kept under institutional/Home quarantine as per Standard Operating Procedures (SOPs) in Government facilities or will have the option to stay in identified hotels on payment basis.

• Any person violating the above directions shall be liable to be fined Rs.5000/- each time.

Passenger obligation

Arriving Passengers

• All incoming passengers shall MANDATORILY carry RT-PCR negative test report issued from an ICMR approved Labs, subject to the condition that RT-PCR test should have been taken within 48 Hrs prior to boarding for Port Blair from mainland and produce the Test Result / Report at the originating station and also at ITF ground, Port Blair for verification with SRF ID No. for validation.

- Self declaration forms to be filled by passenger which is handed over while de-boarding.

In addition to above, the RT-PCR test will be conducted at free of cost on all incoming passengers by transporting all passengers to ITF ground through buses by administration to get tested for RT-PCR.

- Luggage will be handed over to passengers at ITF ground after undergoing the RT-PCR test.
- Report of RT-PCR will be available in 1-3 days via phone number provided in Self Declaration Form.
- All incoming passengers from mainland to undergo compulsory home quarantine or institutional quarantine until the reports of their test on arrival at Port Blair are found negative. Any person violating the above directions shall be liable to be fined to the tune of Rs.5000/- each time.
- Passenger found positive as per the test done on arrival at Port Blair shall be kept under institutional/Home quarantine as per Standard Operating Procedures (SOPs) in Government facilities or will have the option to stay in identified hotels on payment basis.
- Proper wearing of masks is mandatory

Passengers who are not carrying proper negative RT-PCR reports shall not be boarded for the Port Blair flight

• All arriving passengers need to cooperate with airline staff and officials verifying the RT-PCR report at origin boarding points and performing the RT-PCR test at ITF ground

Departing Passengers

Passengers having safe status in the Arogya Setu app and only those who are wearing masks, asymptomatic, are allowed inside the airport

Airline obligation

- To make in-flight announcements about the latest order.
- Display Quarantine guidelines of Port Blair airport at boarding points in origin stations.
- Self declaration forms to be handed over to passengers during deboarding and the same need to be given to doctors at ITF ground.
- Protective gears to all the passengers.
- Medical gowns to middle seat passengers.
- Passengers data in the given format to be shared with District Authorities as deputed by DC South Andaman at the airport.
- Make sure that passenger luggage is handed over safely to passengers at testing centres.

- Reports of only those pathology labs will be acceptable, which have been approved and certified by ICMR. If ICMR ID and SRF ID are not mentioned in the report, then passengers will have to undergo RT PCR test at the airport.
- Passengers having certificate for both doses of vaccination will also have to show a negative report of RT-PCR done within 96 hours of arrival at the Airport.
- If such passengers don't have the report, they will have to undergo RT PCR test at the airport.

Passenger obligation

- Reports of only those pathology labs will be acceptable, which have been approved and certified by ICMR.
- If ICMR ID and SRF ID is not mentioned in the report, then passengers will have to undergo RT PCR test at the airport.
- Passengers having certificate for both doses of vaccination will also have to show negative report of RT-PCR done within 96 hours of arrival at the Airport.
- If such passengers don't have the report, they will have to undergo RT PCR test at the airport.
- At the time of providing samples for RT-PCR test, passengers will have to provide their photo, ID and mobile no. Also, they will have to get their mobile nos verified by giving missed call to the inspecting official.
- Passengers not having mobile nos shall get the missed call done by their relatives' mobile nos.

Airline obligation

- All airlines disseminate the information regarding passenger obligation as mentioned above at the time of booking to avoid any inconvenience to passengers.
- Airlines need to inform the passengers about the latest guidelines issued by the state government.





Airline obligation

• Aurangabad, Jalgaon, Kolhapur, Nagpur, Nasik, Pune, Shirdi - Arriving passengers details with name, mobile number, residential address etc.to be shared with State Nodal officer. If passenger found symptomatic upon arrival, airline will guide passenger along with their bags to the dedicated medical room

• **Mumbai** - To check passengers arriving from any State to Mumbai who are not fully vaccinated are carrying 72 hours prior RT-PCR Negative test report with them. Airline to comply with dedicated deployment of senior officials and other assisting staff 24x7 for COVID operations.

• **Nanded** - Detailed list of arriving passengers, residential address to be shared with Nodal Officer. If a passenger is found symptomatic upon arrival, the Medical team of Municipal Corporation will guide the pax about the further procedure.

• **Shirdi** - Detailed list of arriving passengers with arrival flight, time, mobile number and residential address to be shared with Nodal officers. If a passenger is found symptomatic upon arrival, the airline shall handover the passenger to the Medical team for quarantine at passengers cost.

Airport or State obligation

• Aurangabad, Jalgaon, Kolhapur, Mumbai, Nagpur, Nasik, Nanded, Pune, Shirdi - Thermal screening shall be done for all passengers. RT-PCR Testing Facility available at the airport for passengers arriving from any state except at Kolhapur Airport.

1. Elderly passengers above the age of 65 years.

2. Pregnant woman in advanced stage of pregnancy.

3. Both parents are accompanied below 5 years of age.

4. Passengers having serious illness and require immediate medical attention such as cancer, severe physical disability, mental illness, cerebral palsy on production of supporting documents and medical conditions that need admission in a medical institution immediately.

5. Extreme family distress condition i.e. father, mother, son, daughter in critical condition (on death bed), severe accident in family, death of immediate family member (only on production of convincing support document to the airport staff).

6. Passengers who have completed their both COVID vaccine dosage (on production of both vaccination certificates and also a self declaration in prescribed format).

7. Medical professionals that intend to travel for performing life saving surgery/attending critical patients (on production of proof from the hospitals where the surgery/medical service is intended to be performed).

The above categories passengers may be considered exempt from institutional quarantine subject to providing required documents to the satisfaction of the In- Charge officer at the airport.

• **Nagpur** - 7 days Institutional Quarantine and 7 days home quarantine are mandatory for those passengers who are travelling from Middle East, European Countries, South Africa and UK.

• **Pune** - Not Applicable - Only 14 days self monitoring of health for those passengers possessing valid negative RT-PCR test report.

Home quarantine

• **Mumbai** - 07 Days, For all International passengers arriving from Middle East, Europe, UK, South Africa and Brazil. 14 Days for International passengers arriving from countries other than specified above.

• **Nagpur, Pune** - For RT-PCR negative test report passengers, No Home Quarantine but self monitoring of health by passengers.

Health screening

Mumbai, Nagpur, Pune - Thermal screening for all passengers.

Covid test

• **Mumbai** - Passengers transiting to Domestic sectors outside Maharashtra are required to undergo RT-PCR test before connecting to their onward flights.Passengers arriving from UK, Brazil and South Africa are required to wait for the test results at the airport before connecting for their onward journey.

• Nagpur - Not applicable

• **Pune** - All passengers arriving from UK, Brazil, South Africa and Middle East are required to undergo RT-PCR testing on Arrival at Pune Airport. Transit passengers arriving from Brazil/UK/ South Africa and taking connecting domestic flights, need to undergo RT-PCR test and wait for Test Results (should be negative) before they board a domestic flight. Any Transit Passenger found positive will be shifted to the nearest COVID Isolation facility.

Passenger obligation

• **Mumbai** - Passenger to upload Negative RT-PCR test report within 72 hours prior to undertaking the journey as well as self declaration form on Air Suvidha portal. - At the time of boarding the flight, only asymptomatic travellers will be allowed to board after thermal screening. All passengers shall be advised to download the Aarogya Setu app on their mobile devices.
- During boarding all possible measures for physical distancing are to be ensured.
- Suitable announcement about COVID-19 including precautionary measures to be followed shall be made at airports and in flights and during transit.
- While on board the flight, required precautions such as wearing masks, environmental hygiene, respiratory hygiene, hand hygiene etc. are to be observed by airline staff, crew and all passengers.
- De-boarding should be done to ensure physical distance.

- Residents of any NE state who is arriving in Nagaland and is a transit passenger and directly travelling onwards to any North East state should have Negative COVID-19 report or vaccination completion certificate and also satisfy the SOP of the final destination state.
- For dignitaries and senior Govt officials entering the state, the Home Dept will provide necessary facilitation and make arrangement for their testing after entry
- In case of officers/staff/personnel of military/paramilitary entering the state, the respective unit will make arrangements at POE for transportation to respective units.
- The arriving passengers are also required to submit undertaking/declaration at POE as per annexure.

Health Screening: Thermal screening shall be done for all passengers

COVID test: COVID RT-PCR test shall be done at the airport for all passengers coming from Europe, Middle East, Brazil, South Africa and the United Kingdom.

Passenger obligation

• Passenger should submit self-declaration form on the online portal (www.newdelhiairport.in)

• Passengers must carry COVID-19 RT-PCR negative reports. This test should have been conducted within 72 hours prior to undertaking the journey.

• Exemption from carrying RT-PCR Test report-

Those traveling to India in the exigency of death in the family. If they wish to seek such exemption, they shall apply to the online portal (www.newdelhiairport.in) at least 72 hours before boarding. The decision taken by the government as communicated on the online portal will be final. OR, otherwise, those pax who have completed their two recommended doses of covid vaccine, 28 days prior to their travel to the State of Rajasthan, would neither require any RT-PCR Negative report, nor would be quarantined, be home or institutional.

Airlines obligation: Make passengers aware to follow social distancing and safety protocols/guidelines provided by the government.



• Passengers with onward connecting flights from Delhi are exempted from the above mentioned requirements

• All Constitutional and Government Functionaries and their staff members accompanying them who are travelling to NCT of Delhi from the state of Andhra Pradesh and Telangana on official work are exempted from the aforesaid instructions, if they are asymptomatic. However, they are advised to self-monitor their health for next 14 days and shall strictly follow the COVID-19 related guide-lines/instructions/SOPs issued by Government of India as well as Government on NCT of Delhi from time to time and perform minimum necessary travel as would be required to perform the work for which he-she has arrived in Delhi.
